

Dear Friends.

On behalf of the Tampa General Hospital Foundation, I am pleased to report that 2008 was a successful year, and we raised over \$6.8 million. Our achievements would not have been possible without the generosity of the many individuals, corporations, and foundations that support us throughout the year. We are especially grateful for the support we receive from the TGH Medical Staff.

This Annual Report gives you a snapshot of a "moment in time" in the new Bayshore Pavilion. During our 2008 Annual Dinner, we proudly presented Tampa General with a check for \$10 million from the proceeds of "Building on Excellence," our first ever capital campaign. This campaign for the Bayshore Pavilion was conducted under the able and skilled leadership of Stella Thayer and Jim Warren.

A few highlights of this year's fundraising success include our capital campaign, special events, and the support of Tampa General's employees:

- We completed our 2nd capital campaign, named "Tiny babies. Big priority." It exceeded our \$7 million goal towards construction of the Jennifer Leigh Muma Neonatal Intensive Care Unit.
- Our signature events raised over \$650,000, thanks to our sponsors, those who attended the events and the dedication of the volunteers who organized them.
- Hospital employees contributed \$135,000 through their Annual Employee Campaign, which is a spectacular achievement.

During the year, we funded a myriad of projects and programs. We provided infant car seats for all of our new babies, books for the pediatric patients at Healthpark, specialized equipment, and we helped fund burn camp for pediatric burn survivors, and much more.

People are motivated to support Tampa General for many reasons. Some give in gratitude for the care they or a loved one received at the hospital or because they have been personally affected by some specific disease. Others simply want to support TGH in recognition of the fantastic care provided to all patients.

The gifts we receive on behalf of Tampa General come in many forms and sizes, and all of them are important. Even a modest contribution, when pooled with other gifts, can be tremendously effective. It can help purchase a needed piece of equipment or provide a service for patients or professional development for hospital staff. For instance, last year alone, through your generous gifts, we were able to provide over 180 employees the opportunity to attend conferences and seminars where they sharpened their skills, received continuing education, shared their research findings, and learned of new programs to bring back to TGH.

As you know, 2009 is expected to be a challenging year for foundations and not-for-profit organizations, and we sincerely appreciate all of your efforts. On behalf of the Foundation Board of Trustees, the physicians and employees of Tampa General, and, most importantly, our patients and their families, thank you for your continued support.

I hope that you enjoy reading how your gifts have made an impact at Tampa General this past year. Respectfully.

# Making a Difference

Unrestricted gifts starting at \$1.00 and going up into the thousands are pooled together in our Fund for the Future. The TGH Foundation Board then approves expenditures for priority needs of the hospital so that we can continue to deliver exceptional care every day.

All of our patients have different needs, and the children who are patients in the Children's Medical Center are no exception. This year

the Foundation purchased a Vein Viewer Imaging System to help create a "pain-free" environment for our young patients. Have you ever been stuck with an IV? Did it hurt? Many children have veins that are difficult to find, requiring multiple IV sticks and causing significant anxiety for the patient, the parents and the nurse. The new Vein Viewer uses an infrared light source to image the hemoglobin in red blood cells and make the veins visible on the skin. It's incredible! Thanks to our Child Life staff, our Vein Viewer now looks like a giraffe and has been named Vinny, which actually makes its visits fun for kids. Every pediatric patient needing blood work or an IV benefits from this amazing purchase.

Last year, 5,585 babies were born at Tampa
General. We want every mother and baby to
have the best possible experience at this exciting
time. We know that we cannot prevent all
complications, but we can be prepared for
potential problems. To provide the most realistic
training for our obstetric and newborn staff,
the TGH Foundation purchased a Noelle Maternal
and Neonatal Birthing Simulator. Our staff now
has hands-on training of common and uncommon
obstetric and newborn emergencies to improve

outcomes for mothers and babies, to decrease errors and improve communication and teamwork. According to Pat Barry, RNC, MSN, OB Nurse Specialist, "The Obstetric and Neonatal simulators will be particularly beneficial for multidisciplinary training involving low frequency, high risk complications in the Obstetric and Neonatal populations. These are state-of-the-art simulators that use wireless technology, so that we can simulate a pregnant trauma patient in the ER, or transport the neonate simulator from the delivery room to the Neonatal Intensive Care Unit." Mothers-to-be can be confident in the care they receive at TGH as a result of your collective gifts to the Fund for the Future.

Grants are an important funding source for Tampa General. Our physicians, nurses, and therapists use grant funding to conduct important research. The Foundation applies for grants for equipment and programs. Over the past two years, we have received two grants to fund a new educational project for our patients and families from the Verizon Foundation. The Patient Education Resource Center in the main lobby of the hospital provides easy access to healthcare educational materials for any patient, family member or visitor.

With accurate and reliable resources readily available, patients and their families can make informed decisions about their diagnoses and treatment options. Information about medications, support programs, diagnostic tests, medical procedures, and disease prevention are some examples of the variety of information that is available. The convenience of this resource provides a great service for Tampa General's patients, families and visitors.

# Making a Difference

A combination of gifts designated by donors for Camp Hopetake, Board-designated funds from the Fund for the Future, and monies raised by the Tampa Fire Fighters provided a week of fun and camaraderie for over thirty-five of these special children. Children who have been disfigured by burns are very self-conscious, but they shed their inhibitions during this week with other kids just like them. A gift of \$5,000 from one generous donor gave five children the opportunity to experience Camp Hopetake.

Sometimes gifts come in a form other than money. Throughout the year, the Foundation and the hospital's patients have been blessed by gifts from individuals, companies and their employees and other community organizations. A really special example of this generosity was demonstrated by the employees of Melitta USA who wanted to do something special for the pediatric patients in our Children's Medical Center. They raised money and made personal donations to purchase games and toys for the children to use while staying in the hospital. These are kept in the Lightning Playroom which was jointly funded by Melitta and the Lightning Foundation through proceeds from Glitz and Sticks and are also available for patients too sick to leave their rooms.

As you peruse this annual report, you will see the wonderful new facilities and state-of-the-art programs now housed in our fully-opened Bayshore Pavilion. The TGH Foundation raised \$10 million to help build this new facility for the Tampa Bay community. Gifts ranged from \$5.00 to \$1 million and were contributed by

hundreds of generous donors. All donors should be proud of their contributions to this impressive new facility...their support makes a difference every single day at Tampa General Hospital.

The Women's Leadership Council was formed this year to engage women who want to become more involved with TGH and who want to make a greater impact with their philanthropic support of Tampa General. Members contribute \$1,000 annually, and the collective funds will be allocated to programs or projects selected by the membership. At the third and last meeting of each year, members will vote on how the funds will be used. By pooling their funds together, the women as a group can create a greater impact with their contribution than each would make individually. The Bank of Florida is sponsoring this program so that every dollar contributed by the members can go to the projects.

Tampa General's employees are also some of our best supporters! Not only do they work hard caring for our patients every day, but they also demonstrate their commitment to the hospital with their financial contributions to the annual Employee Campaign. Last year they donated \$135,000 to fund a Garden Retreat and expand

the Integrative Medicine Program, along with other financial needs of the hospital.

This impressive group shows their appreciation by giving back to improve TGH.

The Tampa General Hospital Medical Staff continues to be a huge Foundation and hospital supporter. Over the past three years, the medical staff has donated over \$220,000 to the Foundation. Many members of the medical staff also personally support the Foundation Capital Campaigns and events.

# **TGH Foundation's Special Programs**

The Tampa General Hospital Foundation is proud to support a number of continuing programs that showcase the hospital, provide educational support to hospital employees and give families and friends the opportunity to honor and memorialize their loved ones.

#### White Coat Mini-Internship Program

TGH's White Coat Mini-Internship Program allows community and business leaders to experience a major teaching hospital from an insider's point of view. Each intern is paired with a Tampa General physician for an entire day. Nothing is prearranged or "sugar-coated." The intern accompanies the physician everywhere—on rounds, in patient consultations and even in the operating room. Our goal is to give the interns a real day in the life of a physician—the intensity, the drama and the complexity. It is an opportunity to demonstrate the expertise of our physicians and staff, and also their humanity.

### **Innovative Nursing Scholarship Program**

The fact that the United States is experiencing a nursing shortage is well documented. With baby boomers aging, the need for health care growing, and nursing colleges and universities trying to expand enrollment levels, many organizations are seeking solutions to this growing problem. Tampa General Hospital is no exception.

In determining the best way to address the nursing shortage at TGH, internal research revealed that TGH staff members who wanted to become nurses had difficulty balancing work, school, study time, and family. Cutting back on work hours to allow time for school and study meant losing health and other employee benefits, which most staff members could not afford. Their desire to become RNs was apparent, but the practical feasibility of attending and completing nursing school was extremely low.

Our highly successful and innovative Nursing Scholarship Program is designed to give TGH employees the opportunity to attend nursing school full-time while working part-time and continuing to receive the equivalent of a full-time salary and their full employee benefits. Mentors at the hospital and universities advise the students throughout the program.

Upon completion of their degrees, the scholarship recipients must agree to work full-time at TGH as RNs for the same length of time they were in the scholarship program after passing the Florida Board of Nursing exam. Every day, one of these new nurses is taking care of patients at Tampa General Hospital, thanks to this special Foundation program.

#### The Golden Tree of Life

Tampa General Hospital Foundation's popular commemorative giving program, The Golden Tree of Life, provides a wonderful way to celebrate the birth of a child, a graduation or wedding, an anniversary or retirement, or the life of a loved one who has passed away.

Gracefully adorning the main lobby of the hospital, The Golden Tree of Life tangibly recognizes a commitment to caring. Purchasing a leaf or a stone provides a lasting vision of hope and encouragement for the thousands who visit Tampa General Hospital each year.
